Requests to Help-A-Child Grow

Since 1993, HCEA members have been helping improve student attendance and performance through their contributions to the HCEA Help-A-Child fund. The fund is a joint effort of HCEA and HCPSS Pupil Personnel Workers. It assists students who are missing school or not fully participating because they lack appropriate

clothing, medical supplies or prescriptions, glasses, school supplies, etc. Some financial resources are available to PPWs for this purpose, but the need for additional funds and for quick response to emergencies gave rise to the fund.

Every dollar contributed goes directly to assist students whose needs are identified by Pupil Personnel Workers, guidance counselors, teachers or other school personnel. Agreements with Wal-Mart, Target, Sears, K-Mart, Professional Vision and Giant Phar-

Association Elections Give Members a Voice

In February, HCEA members will elect officers to serve for a two year term beginning July 1.

In addition to officers, candidates for HCEA delegate to both the MSTA and Representative Assemblies (RAs) will also be on the HCEA ballot. HCEA's 85 MSTA delegates will represent HCEA at both the October MSTA Convention and the Spring MSTA RA. HCEA can send 20 local delegates to the July 2005 NEA RA in Los Angeles. HCEA stipends cover travel, housing, meals and other expenses for MSTA and NEA RA delegates.

Members will also receive MSTA ballots in February to elect state delegates to the NEA Convention and a new MSTA Treasurer. HCEA President Joe Staub is running for

Nominations for HCEA officer and local delegate positions open at the January HCEA Rep Council and close at 4 pm on Friday, January 28. MSTA ballots will arrive in schools in early February. HCEA members will receive individually addressed HCEA ballots on Friday, February 18. A nomination form and the election schedule - with instructions and deadlines for ballot return will be found on pages 4 and 5.

Get Involved in Your Association

Why did I become an Association activist? Simple! I spoke up when there was a problem at my school, so I was "elected" an HCEA Rep. I got more active when our contract was broken in 1991. I've stayed active because I believe we each can accomplish more together through the Association than we could ever accomplish alone. It's been the most rewarding professional and personal experience of my 33 year career.

With everyone's workload increasing, am I "crazy" to ask you to take the time to be involved in your Association? I don't think so. <u>Your active</u> <u>involvement</u> is the only guarantee that HCEA will be successful in achieving your goals.

HCEA supports you when there is a problem at your school. But <u>your</u> <u>involvement</u>—calling HCEA, setting up a meeting or filing a grievance—is the first step. Being part of a Rep team at your school—rather than letting one person do all of the work—helps everyone. And explaining why you're an HCEA member and asking others to join is important.

HCEA and MSTA workshops and training programs are always free to members. You can also become

involved as a trainer yourself. Working with an HCEA committee is another way to get involved. Teacher and ESP Negotiations Teams are very time-consuming every several years. Work with other committees, though, requires the commitment of just a few hours throughout the school year. Sub-committees planning HCEA events function just at specific times of the year.

HCEA members also serve on HCPSS advisory and joint committees as part of HCEA's commitment to improving schools. Contact me if you would like to serve on one of these committees or to speak at Board of Education hearings on issues such as school calendar, budget or Board policies.

HCEA elections are coming up. Maybe the experience of being an HCEA delegate is the one for you. However you choose to be involved, I'd like to have you add your voice to mine by becoming involved in HCEA—your professional association.



What's Up with Negotiations?

The "collective bargaining" or "negotiations" process, which gives school employees a say in setting their pay and working conditions, is defined in several ways.

State law defines bargaining groups, subjects that can or cannot be negotiated, and requirements of the bargaining process like bargaining "in good faith" and what happens if an agreement can't be reached. Legal terms, such as "in good faith," have been defined in court cases.

Past negotiated agreements set some aspects of the bargaining process. Article II of the teachers' contract and Article 16 of

the ESP contract, for example, set starting dates and say how a mediator would be chosen, if needed.

Negotiating teams also agree on certain guidelines for negotiations. They agree, for example, that the process will be confidential. This allows the teams to explore alternatives and work out agreements that would not be possible if their discussions were made public.

Within these parameters, HCEA keeps its members informed so members can support Association proposals and vote intelligently on the final agreement. Any "tentative agreement" is submitted to HCEA members for final acceptance or rejection.

Spring Break and the 2005-2006 Calendar

The on-going saga of spring break is an example of the interplay between management prerogative, HCEA advocacy and individual members' activity on their own behalf. The Board of Education sets the school calendar. HCEA is one voice on the HCPSS Calendar Committee, which makes recommendations to the Board. When the question of scheduling make-up days during Spring Break comes up, HCEA speaks up loud and clear. Our members are affected personally and financially affected, when spring break is subject to lastminute change. When members express their individual concerns to the Board and support HCEA's position, this helps resolve issues in everyone's best interest.

Title One IAs Face January 2006 Deadline

Title One Instructional Assistants, who don't have 48 hours of postsecondary education or an AA degree, have until January 2006 to pass the ParaPro Assessment test. HCEA will hold test preparation workshops prior to tests given at Oakland Mills HS in March and April and in other Maryland venues in June. Registration booklets are available from HCEA. HCEA gets NEA Grant

HCEA is one of only four local Associations in the Mid-Atlantic region to receive a 2005 NEA Urban Grant. The grant will fund a series of member meetings by job category and followup activities. Save Those Receipts for Tax Deduction

Teachers, counselors and assistants who work 900 hours during a school year may deduct up to \$250 of qualified out-of-pocket expenses when figuring their adjusted gross income for federal taxes. The IRS suggests that educators keep records of qualifying expenses, noting the date, amount and purpose of each purchase. See the HCEA web site for more information and background.

Student Assistants Recoup Overtime Pay

As a result of HCEA's intervention on behalf of student assistants this fall, a recent HCPSS directive was issued by the Superintendent. It will result in additional compensation for many middle and high school student assistants whose work day increased when the Board of Education extended the middle and high school student day in the fall. Any student assistant who worked additional time, for which he/she has not been paid, should report the additional time worked since the beginning of the school year on the time sheet verification form and have the his/her supervisor countersign it. HCPSS and HCEA have agreed to extend the student assistant work day by fifteen minutes each day through the remainder of the year. Salaries will be increased on a proportional basis.

Information for Candidates

If you wish to be a candidate for an HCEA office, you must:

- 1. Be an HCEA member in good standing.
- 2. Be nominated, or nominate yourself.
- 3. Complete an "HCEA Nomination Form" indicating each position that you are seeking.

All nomination forms must be returned in to the HCEA office no later than 4:00 p.m., Friday, January 28, 2005.

Candidates may also provide a biographical sketch in the space provided on the Nomination Form or on a separate page. The limit for the biographical sketch for a candidate for an HCEA officer is 100 words. Candidates for Delegate to the MSTA and NEA Conventions are limited to 25 words. The information provided in a candidate's biographical sketch will be distributed, unedited, to the membership. Due date for biographical sketches is also January 28, 2005.

MSTA Election Ballots: Arrive Earlier, Due First

Members will receive MSTA ballots during the first week in February, before HCEA ballots arrive in schools on February 18th. Reps are asked to conduct MSTA elections as early as possible and to bring completed ballots to the February Rep Council on February 8th. **Any ballots received after March 4th will not be counted.**

Facts about Maryland

Did you know that:

- Maryland is the second wealthiest state after New Jersey.
- One-third of state general spending pays for free k-12 public education and libraries.
- Another third pays for higher education, health and public safety.
- More than \$80 million was cut from k-12 education in FY 2005.
- Tuition and fees at Maryland public colleges and universities among the highest, 36% more than the national average.
- \$122 million was cut from the higher education budget in FY 2004 and FY 2005.
- Pensions for Maryland teachers and school employees are among the lowest in the United States.
- Funds to protect Maryland's environment has been cut 17% in the last 2 ½ years.
- Maryland faces a \$300 million budget shortfall for FY 2006 and more than a billion dollar shortfall in each year thereafter.
- Maryland is one of only a handful of states where state and local spending for programs has declined relative to personal income.
- Only about 1/3 of Maryland corporations pay any state corporate income tax.
- Maryland ranks 50th among states in the total share of local and state taxes paid by business.
- Within 2 ¹/₂ years, balancing the state budget without new revenues will require cutting \$1 out of every \$8 in state spending.

Negotiations Begin

The teachers' negotiating team met for the first time with the Board of Education negotiating team on Monday, December 20th. They presented and explained the team's proposals. The ESP negotiating team had its first formal meeting with the Board's ESP negotiating team on Monday, January 10th. HCEA will be publishing regular
