#### **Agency Fee Update**

After several unproductive negotiations sessions between HCEA and the Board of Education during the summer months, HCEA has sent a letter to the School Board requesting that an impasse be declared in negotiations over the agency fee issue.

The provision for agency fee or "fair share" for HCEA was passed into law by the General Assembly in April and signed by the Governor in May. This law provided the right for HCEA to negotiate with HCPSS the terms for implementation of a fee for services rendered to non-members as required by law. Despite the fact that our lawmakers made clear through this legislation that they wanted this fee to become effective July 1st for all nonmembers, the BOE has continued to stonewall these efforts by demanding that all current employees be exempted, as well as attempting to set a threshold of membership that HCEA must attain for both teachers and ESPs before the fee can take effect.
