Inauguration Day Leave

Questions are arising about allowances for students and staff to attend the Presidential Inauguration. Staff absences that day are to be handled as usual. This is an appropriate use of personal leave. Please be aware that you may not use this as a "banked" day. We understand that there will possibly be a large number of staff absences and, therefore, we will assist schools in covering classes (a process will be forthcoming).

The schedule for ending the second quarter and for completing report cards prevents us from making major changes to accommodate families wanting to participate in the activities of the day. Likewise, we cannot eliminate the high school mid-term exam scheduled for the Presidential Inauguration Day.

However, for consistency across the county, I am recommending that principals allow parents to use one of the three discretionary days of

absence provided for each child if they wish their child to attend the inauguration. This applies to high school students as well, recognizing that Policy 9010, Attendance, says that parents are not to request the use of discretionary days on an exam day without the authorization of the principal. If the discretionary day is arranged with the principal in advance, participation in inaugural activities will be an excused absence for students at all levels.

As usual, all missed work must be made up, and high school students who miss a mid-year exam will be expected to make up the exam at the teacher's convenience by the end of the mid-term exam week. When parents make the request for the absence, it will be appropriate to remind them of their child's obligation to make up the missed work and tests.

Thank you to each and every one of you who helped to make our Association victorious on election day! At the local level, HCEA was successful in helping to elect all three of our endorsed candidates to the Board of Education. Current school board members Janet Siddiqui and Ellen Flynn Giles were re-elected. Newcomer Allen Dyer won the third spot, narrowly defeating a candidate for the final seat that supported merit pay, vouchers, teaching of Creationism and who home-schools her child. At the State level, MSTA recommended Frank Kratovil for the vacant seat in the First Congressional District. He ran on a "Pro-Education" platform and in a major upset he was declared the winner after absentee ballots were counted. Also, the ballot initiative supporting the slots referendum won on election day! This will provide for an infusion of much needed revenue for education funding in Maryland. For NEA, and all of us, the election of Barack Obama and Joe Biden as President and Vice President of the United States was a victory we can all be proud of! Whether you served on our Government Relations Committee and interviewed candidates, worked at the polls on election day, shared Association recommendations with family and friends or stood in line to vote on election day, your actions were an important part of the process that benefited public education! And given the fact that two elections came down to the counting of absentee ballots, HCEA and MSTA members can be proud of our efforts in making the difference in these two elections!

But our political efforts do not end with the elections. Now we must hold these elected candidates accountable for following through on their campaign promises. Less than two weeks after the election, dozens of HCEA members gathered early on a Saturday morning to meet and talk with members of our General Assembly delegation and County Council to discuss funding issues, creation of a statewide neutral process to resolve contract and labor disputes, ways to improve



student achievement and other matters of educational interest. To those elected officials who took time to meet, we thank you. Your continued willingness to support public education and listen to our concerns is greatly appreciated. And thank you to all of the HCEA members who came in the rain, some who brought along family, and FEA students who shared their experiences in the school house. A future forum will also be scheduled for HCEA members to meet and discuss issues with our elected School Board members as well.

This election shows that we can be successful if we all work together!! Congratulations on all of your efforts that led to victory on November 4th. Now the really hard work begins!

Next year, State funding for public schools is supposed to increase from the current amount of \$5.418 billion to \$5.632 billion, an increase of \$214

million. The \$214 million increase is composed of \$130 million more for the state's contribution to fund educator

pensions, \$35 million for Thornton Formula direct aid to counties, and \$49 million more for GCEI, the Geographic Cost of Education Index. Already, county governments are demanding cuts to local school budgets, and many systems have imposed hiring freezes or cut programs, or are threatening furloughs.

While Howard County has so far been spared hiring freezes and cuts to crucial programs, cuts in the state budget could impact us. We need you to urge your state legislators to, at a minimum, maintain the FY09-

FY11 funding levels agreed on in last year's special session. Because of the national economic crisis, state and local revenues have dipped far

below original projections, and as a result, achieving our goal of staying the course on education funding will not be easy.

The Governor and key legislators are already trying to figure out how to close the expected gap of more than \$1 billion in the FY10 state budget and have said that everything is on the table.

We need each and every member to contact your legislators through MSTA's site to urge them to protect education funding. You can do this by going to the GPS campaign website, www.GreatSchoolsMaryland.org and clicking on "Take Action" at the bottom of the page. The really hard work begins now!
