# Northfield Contributes to Help A Child

Northfield Elementary School recently conducted a Math-A-Thon and raised \$8388.32 for the Help A Child fund. According to Rep Rita McMullin, the event is co-chaired by Karen Geissler and Nancy Holmwood. Students find donors to pledge a certain amount for each correct problem they solve in a given period of time. Members of the PTA are also involved serving on the committee, checking problems and counting the proceeds.

Money has been raised in the past for Cystic Fibrosis, the Red Cross on behalf of Tsunami victims and Brock Elementary School in New Orleans in the wake of Hurricane Katrina. The Math-A-Thon is held every other year, alternating with a Jump Rope for Heart. "We feel that it has been a very successful endeavor and are delighted that the children at Northfield are exposed to the problems of other children in the world and are able to help these children who are so needy," said Rita McMullin. # The View from Here

"Howard County Public Schools continue to be an outstanding success because of the work you do and we thank you for your service." Another school year is ending. Good job! Many of you will be spending the next two months taking classes, working part-time jobs, spending time with family, vacationing, or just kicking back and relaxing. Those of you who work eleven or twelve-month positions will be able to relax a little more when schools are closed.

Howard County Public Schools continue to be an outstanding success because of the work you do and we thank you for your service. Work in public education, although highly rewarding, can be difficult, demanding, and thankless. As demographics change and more fragile children with greater needs enter our classrooms, many expect our schools to fill in where traditional support systems fall short or are non-existent. When the demands of "No Child Left Behind" (The Elementary Secondary Education Act), TIENET, endless assessments, and other workload issues exacerbate an already difficult situation, it is not surprising that the recently released HCPSS Separation Report was filled with teachers in their first three years of the profession. On the positive side, the retention of paraprofessionals is higher.

Let's look at a few of our successes:

- Our Contracts will be funded without drama!!! In meetings with my counterparts from other counties in Maryland and for other states, it must be noted that we are one of the few systems without major funding concerns. We owe that in large part to the mutual respect and collaborative relationship HCEA has established with the community, the County Council and County Executive, and the Board of Education and Superintendent. Our contracts were honored and the cuts to education were not draconian.
- Fair Share went into affect on December 1, 2007. Individuals hired on or after that date, who choose not to join HCEA, will have to pay a representation fee.
- Membership is up by nearly 400 members.
- HCEA's Legislative Breakfast had the best attendance yet.
- HCEA and HCPSS held it first Community Meeting.
- The Annual HCEA Crab Feast was completely sold out.
- The Annual Job Satisfaction Survey continues to be respected by HCPSS and the media.
- HCEA's New Para Orientation was well attended and highly successful.
- We have a rep in every building!

# **Rule Change Proposed**

The MD State Department of Education has proposed a rule change that, based on analysis by MSTA staff, would no longer allow certain "Specialists" (Speech-Language Pathologists, Occupational/Physical Therapists, and Audiologists) licenses to be treated as "professional (teacher) certificates." If passed, the impact of the change would remove these educators from the teachers' collective bargaining unit. This would affect: working conditions, tenure rights, retention/recruitment, and retirement. The proposed change is being championed by the Office of the State Superintendent.

There are two phases of this process. First, the State BOE must approve the change. Second, the Professional Standards and Teacher Education Board (PSTEB) must also approve the change.

#### We Have the Power to Defeat this Move!

<u>In our favor</u>— There are numerous MSTA members on PSTEB (including our own Judie Cephas) who we are confident will reject the proposed change.

<u>Our challenge</u>— The State BOE has NOT traditionally been a friend to us.

HCEA President, Ann De Lacy is sending a communication to all of our members affected. She is also touching base with HCPSS (Dr. Cousin and his staff) to make sure they understand the negative impact of this proposal and to solicit support for our efforts to defeat it.

#### <u>What You Can Do</u>—

You do not need to be a "specialist" (as defined) to make your concerns known. Here are key dates and actions you can take:

- June 6-July 7, 2008— 30 Day public comment period for PSTEB (send letters, tell your stories)
- August 7, 2008— Public Hearing in front of PSTEB at the State BOE office in Baltimore (time TBA) (We need to pack the room!)

Donna is a Para Educator at Phelps Luck Elementary School and is a native of Howard County. Starting out by thanking County Executive Ken Ulman for his ongoing commitment to funding the

HCPSS's budget requests, Donna went on to encourage everyone to think outside the box when it comes to finding additional revenue sources. She reminded everyone that Howard County residents want the best of everything whether it is public schools, police and fire protection, libraries, roads or senior services. Unfortunately, many people don't want to pay for the best because it may mean more taxes. "As a taxpayer, do I really want my taxes raised? The truthful answer is no, but in reality the answer is yes - if I want the best," Donna said. She went on to say "People will stop at Starbucks every day for a cup of coffee and pay...almost \$1000 a year. But when it comes to county services we don't want to pay more than we did ten years ago." Donna concluded her testimony by pointing out that to maintain county services we need to maintain an excellent public school system. Well said, Donna!
