efforts to shift the costs of our pensions to the local governments and our battle with Dr. Grasmick and the State Board of Education over Maryland's Race to the Top Grant award.

Those of you who have been around for a couple of decades can remember when cost shifting occurred with Social Security which was once funded by the State of Maryland. Our contracts were broken and funding for public education was significantly diminished. One thing I find very interesting about this effort is that nothing has been mentioned about either cutting or shifting the costs of the pensions of State Legislators or judges...I wonder why?

The same Dr. Grasmick who insisted that Maryland have the smallest student subgroups in the United States under "No Child Left Behind," now wants to mandate to local school systems that 50% of all certificated staff evaluations be based on student growth. Thirty percent will be based on an MSDE assessment and twenty percent from the local school system assessments. The Education Reform Act of 2010 clearly spells out the process for developing teacher and principal evaluations. The Act gives full authority to local school systems and their employee representatives to create their own effective evaluation system and determine 100% of the evaluation criteria, not 70% as Dr. Grasmick and the State Board of Education maintains. Please contact Donna Hill Staton, a Howard County citizen who serves on the MSDE Board, at 410-767-0467, and let her know how you feel about this decision.

Thank goodness I have some very good news to report. During a meeting on November 22, 2010 with Marius Ambrose, Linda Wise, Mamie Perkins, Terry Alban, Ray Brown and me in attendance, Dr. Cousin announced that HCEA and HCPSS will work together in equal partnership in developing an evaluation model for the "teachers" within our certificated bargaining unit. We can also celebrate the fact that those part-time employees who were forced to take full-time positions because they were afraid of losing health care benefits will be given priority over new-hires for part-time job openings for which they are qualified.

You will be able to learn a great deal more information about these and other issues at our HCEA Legislative Breakfast on Saturday, January 22, 2011 from 8:30 a.m. to 11:30 a.m. at Linden Hall which is located in Dorsey Hall. All elected officials in Howard County will be formally invited to this event.

TURN Conference

The TURN (Teacher Union Reform Network) Conference was held in San Antonio, Texas this past September. President Ann De Lacy, Teacher Heather Smith, and UniServ Director Sarah Johnson attended. Among the presenters was Joe Anderson, US Department of Education, who was asked tough questions by Union Representatives from around the Country about Race to the Top, and how classroom teachers became the "targets" in Public Education reform. Mr. Anderson acknowledged that the Public Education System is broken, and promised to take back

the concerns he heard regarding teacher evaluations to U.S. Secretary of Education Arnie Duncan. He further acknowledged the representatives' frustration with the Administration's silence over the negative messages being sent regarding Public Education and Educators by films like Waiting for Superman, and indicated that the NEA and AFT had clearly sent the message to the President that he should no longer be silent on this issue.

The Conference also focused on different methods for teacher mentoring and evaluations being used across the Country. The most successful models are those that are negotiated between the school system and the union with joint oversight and continual monitoring. The next meeting will be held in January, at which time some of the successful models from the Northeast Region will be further explored and discussed.

Legislative Breakfast

The annual HCEA Legislative Breakfast will be held at 8:30 a.m. on Saturday, January 22nd at Linden Hall. According to GR Chair Paul Lemle this year's event is more important than ever. "With our pensions on the chopping block and the details of Race to the Top still to be worked out, we need to make sure our elected officials hear our member's concerns. It's critical that they talk with the people actually in the school houses in every capacity to get a clear picture of how their actions will impact the classroom and our members."

Advocacy Reminders

As first semester winds down. there are some important reminders for deadlines according to your Negotiated Agreements. For tenured teachers, if this is your formal evaluation year, you should have one observation prior to the end of first semester. Non-tenured teachers, you should be observed twice before the end of first semester. Observation Reports must be received within five school days of the observation. ESP members, if observed, your post observation conference must be requested and occur within five duty days of the observation. If any employee receives an Observation Report that they disagree with, you have the right to write a rebuttal to that report and have it attached in your file. If you have any questions regarding your rights, please contact your UniServ Director.
