# The View from Here

Race to the Top (RTTT), as defined by Wikipedia, "is a \$4.35 billion incentive program designed by the U.S. Department of Education to spur reforms in state and local district K-12 education." RTTT is funded by the Education Recovery Act as part of the American Recovery and Reinvestment Act of 2009 and was announced by President Obama and U.S. Education Secretary Arne Duncan in late July 2009. Grants are given based on states competing with each other to receive monetary awards as a result of a scoring rubric. The application calls for the applicant to take bold steps in school reform.

In order to secure much desired funds in a time of severe economic distress, many states, including Maryland, have written into law "reforms" that require that a significant portion of teacher evaluations be tied to student test scores. With the exception of Montgomery County and Frederick Counties, the other twenty-two school districts, including Howard County,

endorsed Race to the Top and signed the Memorandum of Understanding. One thing to note is that Prince George's County Education Association President, Donald Brisco, was the only NEA local president to sign the Memorandum of Understanding.

Maryland's new Education Reform Act requires a significant component of teacher and principal's evaluations be based on student achievement (SBOE pushing for 50%). And it changed teacher tenure (the right to due process before firing) from two years to three.

HCEA is strongly committed to public education. We believe it is vital in ensuring America's role as a thriving democracy. It is our responsibility to collaborate with other education and community stakeholders to achieve greater levels of student achievement and to strongly advocate closing the achievement gaps between students who are more advantaged and those who are economically challenged.

During contract negotiations, HCEA always attempts to include instructional and professional issues that will allow us a greater role in determining our educational practices, professional development experiences, decide how we are evaluated, and to work reads Diane Ravitch's book! collaboratively in deciding how to deliver instruction. At forums, we

forcefully speak out against silver bullet/flavor-of-the-month overhauls that are usually expensive, untested and provide (at best) short-term results. We believe these teach-to-the-test "reforms" stifle creativity with drill and kill strategies that dull the senses of the very children that we need to

Diane Ravitch, in her book, THE **DEATH AND LIFE OF THE GREAT AMERICAN SCHOOL** SYSTEM, quotes then Superintendent of San Diego Public Schools, Carl Cohn, with the following declaration: "School reform will continue to fail, until we recognize that there are no quick fixes or perfect educational theories. School reform is a slow, steady labor-intensive process that depends on harnessing the talent of individuals instead of punishing them for noncompliance that bureaucratic mandates destroying their initiative. Ground-level solutions, such as high-quality leadership, staff collaboration, committed teachers, and clean and safe environments, have the best chance of success. These solutions are not easily quantified. They cannot be experimented on by researchers or mandated by the federal government."

# Fairness in Negotiations Act Passes!!

After more than 20 years, MSEA organized members and rallied legislators to pass a badly needed fix to Maryland's antiquated education labor law. The Fairness in Negotiations Act (FINA) finally levels the playing field in negotiations between local school boards and local associations. The measure, which passed the State Senate last year, was approved in the last hours of the 2010 General Assembly with a vote of 33 to 14 in the Senate, and 103 to 34 in the House of Delegates. Passage of FINA means that the Howard County Board of Education can no longer drag negotiations on and on, keeping us from hard-fought improvements in benefits, salary, and working conditions. Now, a neutral labor relations board must resolve labor disputes between HCPSS BOE and HCEA within a specific time frame. The decision will be final and binding for both parties. If either party disagrees with the decision of the labor relations board, the dissenting party can appeal to the circuit court.

#### How it works

Before an issue rises to the level of an appeal to the new labor relations board, a mediator will bring the two sides together for discussion. Most disagreements are settled at this stage. If the two sides fail to reach agreement, the parties can proceed to dispute resolution with an arbitrator.

Under FINA, the entire appeal process is limited to 104 days. Before FINA, the process could take a year or more. FINA is likely to encourage both sides to reach agreement earlier.

Why FINA is so important
Before the passage of FINA, the
State Board of Education decided what could and couldn't
be negotiated at the local bargaining table. To no one's surprise, the board's decisions often favored management over
employees. According to FINA
sponsor Senator Jamie Raskin
(Dist. 20), it was, "like having
your opponent in a sporting
event supply the referee."

## **New Contract Ratified**

Congratulations to the two HCEA bargaining teams on their recently completed contract negotiations. Both the contract for certificated and non-certificated staff included step increases for those who were eligible; those who were not eligible will receive a \$500 salary increase. Tuition reimbursement stipends also increased. And layoffs and furloughs were avoided. Although the new contracts certainly did not reflect what faculty and staff deserve, this year HCEA was one of the few Associations in the state able to negotiate

any salary increases at all for the coming year. Good job!
