## Why Didn't HCEA Support The Race To The Top Grant? By Paul Lemle, HCEA President

While the period of consideration for the Race To The Top-district grant is over, the conversations about it are not. Like HCEA, HCAA (representing principals) did not support RTT-D. There were several interrelated issues that impacted HCEA's decision:

- ◆ *Lack of collaboration/insufficient time*—HCEA was not a participant in the writing of the grant. The writers were sequestered and the application itself kept secret until its completion. Because the grant was completed on October 28th, and approved by the Board of Education on October 31st, neither HCEA nor HCAA was able to meet in order to make informed, democratic decisions.
- ◆ Inappropriate emphasis on standardized tests Despite statements to the contrary from the Superintendent and staff, the RTT-D grant required that teacher and principal evaluations be dominated by state mandated standardized tests.
- ♦ MSDE inflexibility MSDE insisted on two things: that student growth be 50% of an educator's evaluation, and that state tests should be 30%. We approached them for flexibility and they steadfastly refused. The Howard County Board of Education was asked by HCEA, with more than a thousand signatures, to withdraw from Race To The Top, and it failed to even discuss the matter.
- Consideration of contract—Simply put, you can't sign something you can't see. We were unable to determine or even discuss who would be required to work nights or provide online support for students, what professional development would be done, and how educators might be provided time and resources.
- ◆ Inadequate funding—the Department of Education encouraged applicants to seek other sources of funding, as RTT-D costs more to implement than it awards in grant dollars. There was no windfall or "extra" money to be obtained.

Finally, employees of the school system have the right and responsibility to disagree with their employer on matters of policy. No person should face interference or retaliation for engaging in association activity or exercising the right to free expression. This would be in direct contradiction with the intellectual and academic freedom we work so hard to create for our students.
