Social Networking

Social networking spaces like MySpace and Facebook may be a good way to keep in touch with friends but teachers and other education personnel should be careful in terms of creating personal profiles, communicating with students, and sharing sensitive information. As a result of an investigation, the Ohio Education Association (OEA) has issued a strongly worded warning to its members: "OEA advises members not to join [these sites], and for existing users to complete the steps involved in removing their profiles," the memo said. "While this advice might seem extreme, the dangers of participating in these two sites outweigh the benefits."

While HCEA/MSTA have not gone that far, members need to be very careful about what they share online. Individuals need to remember that it's accessible by students and that material may be inappropriate for students – or parents – to see. You probably don't want discontented parents or mischievous students circulating those pictures of you from your college keg party or wet t-shirt contest.

Other concerns have also arisen. Investigations around the country and Maryland involving misconduct underscore the reasons for this concern. The Ohio memo goes on to say "The fact that a student can attempt to contact a ... member who has a profile on these sites lends itself to the possible interpretation of an improper relationship." It goes on, "Because of the high standards placed on school employees and the risk of job and career loss, the OEA recommends avoiding even the appearance of impropriety." All communications with school-age children should be through official school emails only. HCEA thinks this is good advice. If you participate in a social network website, review the material you have posted and remove any material that may be inappropriate given your employment as an educator.

"When you are asked to make a pledge, please say "Yes."" Dear Fellow HCEA Members,

Sometime near the end of the month of February, you will receive a call at home asking for a contribution to the *Fund for Children and Public Education*. When you are asked to make a pledge, please say, "Yes."

Why do we to ask for this money? One important reason is that we cannot use dues monies for politics. We rely on your continued commitment to the FUND to move our public education agenda forward through legislation. We must ensure, through the election of public education officials, that our members are provided with the tools and resources necessary to education our children.

Why are we involved in politics? The answer is that elected officials or those who appoint them decide each and every important education issue we deal with everyday. The Howard County School Board decides your salary, and all of your benefits, i.e. health insurance, etc. In the face of the current economic climate, our Board of Education, County Executive and County Council have agreed to fund your 5% COLA for next year. The fact that we supported and elected almost all of these people is not coincidental. Other issues affecting you that are determined by elected officials are your class size, length of school year and pension benefits.

The Fund for Children and Public Education is a special fund made up of voluntary contributions from our members. Your contributions pay for the advertising, printed materials, and other voter communications used to elect public officials who support public education and public educators. WE ARE NON-PARTISAN. Once we help people get elected, we then use these funds to ensure that these officials know, on a regular basis, what is important to YOU.



What is going to happen when you are called? The caller is going to ask you to pledge \$5.00 per pay period. We ask that you agree to make a contribution through payroll deduction. This year, we are asking for a minimum pledge of \$5.00 per person but we will not discourage you from contributing more or even less.

The MSTA/HCEA Legislative Agenda in this year's General Assembly focuses on **funding**, an **Independent Labor Relations Board**, **Respect for our Negotiated Agreements, Class Size**, **Workload**, and the **Achievement Gap**. Your donation will help us secure a fair and equitable future for all of our children.

What are "UniServ" Directors?

Your MSTA and NEA dues pay the salaries of professional staff who are trained and experienced in bargaining and contract enforcement; processing grievances and representing members; and providing communication, training, public relations and government relations support to HCEA and its committees. At this time HCEA has 3.4 UniServ Directors who work with members. Marius Ambrose works with certificated staff in middle and high schools and negotiates the contract for certificated staff. Cheryl McLeod works with staff at Homewood, Cedar Lane, ARL and the Board of Education. Dan Collins negotiates the contract for ParaProfessionals and represents ParaProfessionals at all levels. Mary Jo Neville works with certificated staff in elementary schools and provides content for the HCEA Web Page and The Works.
