The annual MSTA Convention's nearly unanimous approval finalized the multi-year MSTA debate to change the Association's name. HCEA Vice-President Donna Schulze, the proposal's stalwart proponent, said, "We all work together for one common goal, to support our students." Education support professionals (ESP) like Washington County president Janice Tucker expect the change to help recruit more members. "They are going to see that the state association is really behind all educators," she said.
