Collective Bargaining Victory for "Specialists"

Thanks to the groundswell of activism and support provided by related service "specialists" (occupational/physical therapists, speech/language pathologists, and audiologists) along with HCEA reps and leaders, members, colleagues, and community members, the Professional Standards and Teacher Education Board (PSTEB) withdrew from consideration a proposed rule change that would have removed these specialists from the Teachers' Collective Bargaining unit. The rule change was championed by Assistant State Superintendent John Smeallie as a reaction to licensure changes passed by the General Assembly. Although prior statements made by the State Superintendent's office to local superintendents and human resources directors suggested that the proposed changes were not substantive, MSTA legal staff, upon analyzing the proposal issued a warning to Dr. Smeallie that these changes had a negative impact on collective bargaining rights of these valuable educators. Once discovered, MSTA staff and the state associations representing these educators mobilized a grassroots effort to defeat the proposed change.

Howard County educators far exceeded expectations! Although the timeframe was tight (a few days before the end of the school year), everyone jumped into
