When delegates at the MSTA **Representative Assembly** voted last October to change the name of the Maryland State Teachers Association to the Maryland State Education Association, it was a historic moment, but one certainly in keeping with the Association's long tradition of inclusion and advocacy.

The View from Here

Happy New School Year!

Each June, HCEA invites retiring members to our office on Dorsey Hall Drive for a little gathering to celebrate the culmination of their longtime membership and years of service. At the end of these sessions, MSEA UniServ Director, Cheryl McLeod, asks those in attendance to share their most memorable moments in education. Following these heartwarming assemblies, Cheryl and I usually smile at each other, lament on how few people attend, and bemoan the sad fact that these stories are not somehow captured and shared.

During a conversation with then retiring Lime Kiln Middle School French/Spanish teacher, Vivian Gentile, the subject of feedback from retirees came up. "I think it would behoove the school system to get feedback from retiring teachers." "Usually we love an opportunity to voice our views," wrote Vivian. "So few people ever ask for them." This past June, a survey, designed by Vivian, was mailed to all retiring HCEA members. One respondent's remarks were so beautifully written and, in my view, captured the essence of the passion behind why one chooses to go into education and, unfortunately, why many leave. These words were written with such clarity that I decided to share them with you. Unfortunately, I am unable to provide credit to the author because no name was attached.

Question 1. What were the reasons you remained in the Howard County School system for so many years?

"I stayed in teaching because I cherished the look in a child's eye when he/she understood. As I became older, I also cherished that same look in the eyes of new teachers when they finally understood the difference between classroom management and classroom control, lesson planning and lesson development, and surviving their profession and thriving in their profession. I get such a thrill when I see an adult who tells me how much they enjoyed my class and learning. They are always quick to share their one special moment."

Question 2. What were the reasons for leaving?

"When I began teaching, I was committed to the calling of educating children. I took my job and my moral responsibility to their education seriously. I talked about students, not because

of 'data' or 'scores' but because it was my ethical responsibility to do so. When a child failed, I saw it as my personal failure as well as my responsibility to help him or her succeed. Something terrible changed to the career I loved. We became a business; a very large, somewhat efficient, and highly impersonal business. We reduced students to IEP's, 504's, and test scores. We institutionalized and regimented conversations about their progress. We set protocols for how we should professionally interact with each other. We had meeting after meeting after meeting. We lost the heart and soul of our profession. I retired because I no longer fit in this new way of doing business.

As a classroom teacher of 38 years (five of those on leave as HCEA President), I am well aware of the many challenges facing those of us who work in public education. Our various occupations, although extremely rewarding, can be filled with roadblocks to success. Irrespective of the role each of us plays within Howard County Public Schools, we hold the future of the children, for whom we are responsible, in our hands. HCEA is here to advocate for you to ensure you have the tools, resources, and support you need to do your job.

Now is the time for FINA: FAIRNESS IN NEGOTIATIONS ACT!

Last year Senator Jamie Raskin, the lead Senate sponsor of MSEA's Fairness in Negotiations Act, called the Senate passage of the labor bill, "a big last-minute breakthrough." The vote in the Senate was 31-13, a strong margin, but it failed to get a vote in the House of Delegates because time ran out.

We are going to restart the clock on January 13, 2010 and with 90 days to get it done we believe this is the year to pass MSEA's Fairness in Negotiations Act. MSEA leaders have worked with members of the General Assembly over the interim and have continued to stress the importance of having an independent authority to resolve differences between the local school boards and the employee representatives. The 2010 bill will address the problem by establishing a process where an independent board will settle labor disputes within a specific timeline and will issue a decision that is final.

Our success in 2009 was a result of our members' grassroots activism. Your phone calls, emails and letters to lawmakers, and visits to Annapolis made a difference. When you get the call to action this year on the Fairness in Negotiations Act, please take the time to participate. This is the year to make a difference!
