
With the help of many members, the wonderful staff at HCEA, staff at HCPSS and others, during the last six years, we have established the following initiatives:

## Changes Coming in Health Insurance

HCPSS has recently completed a process of rebidding all health insurance plans including medical, dental, prescription and vision as well as all voluntary insurance i.e. life, disability, long-term care, etc. with an eye toward reducing overall health insurance costs as well as bringing the number of available plans in line with other school districts. Currently employees have the option of choosing from seven different health insurance plans and many other voluntary plans which has resulted in confusion for employees as well as additional costs to employees and the system.

An HCPSS Employee Benefits Committee was established earlier this year and has met on multiple occasions to examine and interview companies who have submitted RFP's (Request For Proposals) to the BOE. This committee is comprised of representatives from all three employee unions as well as staff persons from HCPSS's health insurance department. The BOE's consulting firm of Bolton & Partners has assisted the committee in its work.

One of the requirements that HCEA representatives insisted on being included in all of the RFP's was a condition that all plan designs had to include, as a minimum, the highest level of benefits in each area from all of the current plans. This will ensure that there is no diminution of the level of benefits cur-

rently enjoyed by employees. The other area that was closely examined by HCEA representatives was the "disruption analysis." This was to ensure that if plans other than current plans were chosen, the physicians currently used by our employees would also be part of those plans.

The Health Benefits Committee has completed its work and their recommendations will be presented to the Board of Education at the June 9th meeting for adoption. If accepted, these plans will go into effect beginning January 1, 2012 and will be included in the open enrollment process in the fall.

### **FBLA Learning Conference**

The FBLA (Future Business Leaders of America) Learning Conference was held on April 6th in Hunt Valley, Maryland. HCPSS educators and FBLA Sponsors Reg Hahne, Marriotts Ridge HS and Teresa Waters, River Hill HS attended the event. Dr. Nancy S. Grasmick, State Superintendent of Schools was also in attendance.

The FBLA is an organization that helps prepare students for the business fields through prebusiness postsecondary study. More than 950 students from around the state participated in this remarkable event; River Hill HS took home the first place trophy while Marriotts Ridge HS placed 3rd amongst the more that 75 participating chapter organizations. Many county students earned the right to participate at the National Learning Conference to be held in Orlando, Florida on June 28th - July 1st.
